Election Bylaws Resolution and Policies Presented

As reported in the November/December Newsletter, the Board of Governors approved Bylaws changes as recommended by the Long Range Planning Committee regarding the officer nominations and election process. Highlights of the changes include moving from a two candidate ballot to a single candidate; extending the timeframe for the membership to submit candidate recommendations to the nominating committee; and removing floor nominations at the annual meeting.

In order to support the Bylaws change expanding the nominating committee, the Board also approved Nominating Committee Policies. These are to provide guidelines for the committee to ensure the most comprehensive consideration process under the single candidate process.

The Bylaws resolution and Nominating Committee Policies are presented on pages 6-7 of this issue and can be found on the MSCPA website (www.ms-cpa.org) under ABOUT. The resolution will be voted on at the annual meeting at Sandestin on June 22, and will become effective for the 2020-2021 candidate slate if passed. MSCPA Monitors Legislation on State and National Levels

With the current Legislative session in progress, the MSCPA continues to monitor bills affecting the profession on both the state and national levels.

On March 1, a meeting was held with Kymberly Messersmith, Managing Director of Political Risk and State Government Affairs at KPGM. She is also Mississippi's liaison in the Accountants' Coalition which was formed in the mid-1990s by the national accounting firms for the purpose of achieving legislative reforms. It has since evolved into its current form of promoting the best business environment for the profession while also promoting the fiscal health and competitiveness of each state. Ms. Messersmith is monitoring legislation in Mississippi and other states and offering assistance and materials as needed. On the national level, the Coalition works closely with the AICPA and NASBA to consider broader policy objectives and discuss key state initiatives. Attending the meeting



were Linda Keng, Legislation Committee Chairman, Karen Moody, President/CEO, and Andy Wright, Executive Director of the Mississippi State Board of Public Accountancy, along with local KPMG members Mark Peach and Ashley Wilson.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE

MISSISSIPPI SOCIETY OF CERTIFIED PUBLIC ACCOUNTANTS

OCTOBER 16, 2018

WHEREAS, the Mississippi Society of Certified Public Accountants (the "Society") is a Mississippi non-profit corporation organized and operating in accordance with the Mississippi Nonprofit Corporation Act (the "Act") codified at Sections 79-11-101 et seq. of the Mississippi Code of 1972, as amended; and

WHEREAS, the Society desires to amend its existing bylaws ("Bylaws") in accordance with Article XVII of the Bylaws and the Act to, among other things, allow for the selection of officers and at-large members of the Board of Directors of the Society through a nomination process that will result in the approval of a nominated slate of candidates proposed by a nominating committee and approved by the members of the Society ("Members") instead of the existing process whereby such positions are filled pursuant to competitive elections among Members; and

WHEREAS, necessary conditions of the adoption of any such amendments (the "Amendments") to the Bylaws in accordance with the Bylaws and the Act is (i) the approval of the Amendments by the Board of Directors ("Board") of the Society following a presentation of the Bylaws amendment at a prior Board meeting, (ii) the approval of the Amendments by at least two-thirds (2/3) of the entire membership of the Board, (iii) the publication of the Amendments to the Members of the Society within sixty (60) days of the final approval of the Amendments by the Board, and (iv) the approval of the Amendments at the next Annual Meeting of the Members by an affirmative vote of two-thirds (2/3) of the votes cast by the Members of the Society at that meeting or by a majority vote of all Members of the Society with voting rights, whichever is less; and

WHEREAS, the proposed Amendments to the Bylaws of the Society were first presented to the Board at its August 7, 2018, meeting.

NOW, THEREFORE, BE IT RESOLVED, that the Board approves, through an affirmative vote of at least twothirds (2/3) of the entire membership of the Board, for the Bylaws to be amended as follows:

1. Section 1 of Article III of the Bylaws is amended so that the following is added as the first sentence of that section:

"Throughout the MSCPA Bylaws, the use of Chairman, Chairmen, or other such terms shall not imply a specific gender & shall apply equally to both genders."

2. Section 4 of Article III of the Bylaws is deleted in its entirety and replaced with the following language:

"Each year, not less than thirty (30) days prior to the Annual Meeting, by notice in the Society Newsletter, the Nominating Committee, with clerical assistance from the Society Staff, shall submit to the MSCPA membership, after approval by the Board of Directors, a slate of candidates for election to fill each office and the at-large member of the Board of Directors. The slate of candidates shall consist of one candidate for each position. In selecting candidates for nomination to office and the at-large member of the Board of Directors, the Nominating Committee, with clerical assistance from the Society Staff, shall solicit and consider any names presented by members of the Society for consideration. Solicitation of names shall be made by notification to members not less than sixty (60) days prior to the Nominating Committee's presentation of the slate of candidates to the Board of Directors. Posting of the said notice in the Society Newsletter or emails to Society members shall satisfy this notice requirement. Each eligible voting member of the Society shall be entitled to vote for approval or disapproval of the candidates for office and the at-large member of the Board of Directors at the Annual Meeting in person or by early ballot prior to the Annual Meeting. Not less than thirty (30) days prior to the Annual Meeting, the President shall send, or arrange for sending, to all Society members notice that they may request an early ballot for the purpose of voting for the officers and the at-large member of the Board of Directors.

Posting of the said notice in the Society Newsletter, emails to Society members, or posting on the Society Website shall satisfy this notice requirement. Such early ballots may be distributed by mail, including electronic mail, or picked up in person, including pick-up by member's designee, by those members who have requested an early ballot. Early ballots must be properly executed and must be received by the Society office by mail, including electronic mail, or in person, including delivery by member's designee, not later than five (5) days prior to the Annual Meeting. Should the slate of candidates nominated by the Nominating Committee or any particular candidate or candidates be disapproved by the membership at the Annual Meeting, then the applicable officer(s) and/or the at-large member of the Board of Directors, whose terms are expiring, will be asked to continue to serve until his/her/their successor(s) are elected at the next Annual Meeting. However, should the applicable officer(s) or the at-large member of the Board of Directors, currently serving, decline to serve for another term, then the Board of Directors shall appoint officer(s) and/or the at-large member of the Board of Directors to serve until their successors are elected at the next Annual Meeting. Furthermore, should an officer or the at-large member of the Board of Directors resign, become unable to serve effectively, or be removed for cause, including but not limited to moral turpitude and/or dereliction of duty, then the Board of Directors shall appoint an officer or the atlarge member of the Board of Directors to serve until his/her successor is elected at the next Annual Meeting.

The Immediate Past Chairman shall appoint an Elections Committee, which shall count both the ballots cast in person at the Annual Meeting and the mail ballots to determine the total ballot count."

3. Section 5 of Article III of the Bylaws is deleted in its entirety and replaced with the following language:

"The Nominating Committee, which shall be appointed by the Chairman of the

Board of Directors, shall consist of seven (7) members: the Immediate Past Chairman of the Board of Directors (who shall chair the committee), three (3) members of the Board of Directors, two additional Past Chairmen of the Board of Directors, and one Past President of the Young CPA Network. Service on the Nominating Committee shall be for a one-year term. The President and Chairman of the Board of Directors shall serve as ex-officio members of the committee for quorum purposes, but without the privilege of voting. Nominating Committee decisions shall be decided by a majority vote of the Nominating Committee.

The Nominating Committee shall be guided by Nominating Committee Policies, which will be approved by a majority vote of the Board of Directors. Future changes to the said Nominating Committee Policies can be made by a majority vote of the Board of Directors."

4. Section 8 of Article IX is deleted in its entirety.

RESOLVED FURTHER, that the appropriate officers, employees and agents of the Society shall be, and hereby are, authorized, empowered and directed to provide the Members of the Society notice of the aforementioned Amendments approved by the Board in accordance with the Bylaws and the Act and prepare such Amendments for presentation to the Members for approval at the next Annual Meeting of the Society; and

RESOLVED FURTHER, that the officers of the Society are authorized, in the name of and on behalf of the Society, to take any and all such actions and to do, or authorize to be done, all such action as the officers, directors, and/or Members may deem necessary or appropriate to effectuate the purposes of these resolutions; and

RESOLVED FURTHER, that any actions taken by the appropriate officers, employees, and agents of the Society prior to the date hereof which are consistent with the foregoing shall be, and hereby are, ratified, approved, confirmed and adopted as the acts and deeds of the Society.

Nominating Committee Policies

The Nominating Committee shall consider prospective candidates, for office and the at-large member of the Board of Directors (hereinafter candidate or candidates), submitted from the membership of the Society in accordance with the Bylaws of the Society. Additional prospective candidates may be submitted for consideration by the members of the Nominating Committee both prior to and as a part of a Nominating Committee meeting. Attentive consideration will be given to all prospective candidates. The Nominating Committee's prospective candidate for at-large board member of the Board of Directors shall be a Past Chairman [which is inclusive of either gender, as in the MSCPA Bylaws] of the MSCPA.

The Nominating Committee shall be appointed, meet, and recommend a slate of candidates to the Board of Directors between July 1 and January 31.

The Nominating Committee shall be furnished, by the President, at least thirty (30) days prior to the first meeting of the Nominating Committee:

- A A list of previous candidates for office and the at-large Board of Directors position over at least the five (5) most recent years. Within said list, successful candidates will be so indicated.
- B Committee Chairmen and Millennial Chairmen over at least the five (5) most recent years.
- C Young CPA officers and members of the Young CPA Board of Directors over at least the five (5) most recent years.
- D Other Society members who have been considered for candidacy in recent years and/or whom the President feels should be considered based on exemplary MSCPA service, longevity of MSCPA service, etc.

The Nominating Committee shall select a slate of candidates from the names considered and only one candidate shall be submitted for each office and the at-large member of the Board of Directors. The said slate of candidates shall be submitted to the Board of Directors for approval and then voted on by the members in accordance with the MSCPA Bylaws.

The Nominating Committee shall be dedicated, first and foremost, to providing the most capable, dedicated slate of candidates possible.

To the extent possible within the overarching goal of providing the most capable, dedicated slate of candidates, the Nominating Committee shall be committed to diversity. While no strict guidelines will be established, the Nominating Committee will strive to select a slate that includes an appropriately representative mix of diversity of the membership of the Society. Considerations shall include, but not be limited to, diversities of race, gender, geography, firm/employer size, public/industry/ academia, etc. The Nominating Committee shall not discriminate on the basis of the aforementioned categories or other categories protected by law.

The qualifications of each candidate shall be considered by the Nominating Committee. While neither the MSCPA Bylaws nor these Nominating Committee Policies call for a specific minimum qualification for each position, the Nominating Committee will provide an increased level of consideration to those candidates with the following history of Society involvement:

- Previous service as Secretary or Treasurer of the Board of Directors
- Previous Board of Directors service in a non-officer capacity
- Committee Chairman or Committee Millennial Chairman
- Positions held as a Young CPA Network officer or on the Young CPA Network Board of Directors
- Positions held within Chapter(s)
- Committee membership
- Other involvement or service to the Society

All decisions of the Nominating Committee shall be settled by majority vote, in accordance with the MSCPA Bylaws.

A tax on parking expenses is a new reality for tax exempt organizations.

No, that title is not a typo. The Tax Cuts and Jobs Act signed into law in December 2017 implements a tax on parking expenses paid by Nonprofit Organizations.

Background

To recoup lost income from the Tax Cuts and Jobs Act, Congress created a new Unrelated Business Income (UBI) for most Nonprofit Organizations. UBI is created when a Nonprofit Organization regularly carries on a trade or business that is not substantially related to furthering its exempt purpose or mission. This UBI is subject to a flat tax rate of 21% and can also create filing requirements and tax due to the state. Any Nonprofit Organization with employees who either (1) pay for parking or (2) park in an Organization-owned or rented parking lot is now subject to this tax. Possibly everyone, right? Congress says every Nonprofit Organization must determine if it is subject to this new tax, which took effect January 1, 2018.

4-Step Determination Process

There are 4 steps to determining the applicability of the new parking tax. If the answer to 1, 2 or 3 is yes, the Organization is subject to the tax and must determine its expenses related to providing parking.

- Step 1: Does the Organization have reserved employee parking spots?
- Step 2: Does the Organization's employees utilize over 50% of the parking lot during normal business hours?
- Step 3: Does the Organization have parking reserved for nonemployees?

Step 4: Determine the employee use of any remaining parking spots.

Case Studies and Examples:

An Organization subject to the UBI tax calculates expenses related to parking, which include but are not limited to repairs, maintenance, utility costs, insurance, property taxes, snow/leaf removal, cleaning, attendant expense, security, rent/ lease expense (if renting) and mortgage interest (if Organization-owned building.) Organizations paying for employees parking in a garage are also subject to this tax. Employers can pay up to \$260 per month for their employees to park. Any amount over \$260 is taxable employee compensation and should be reported on the employee's W-2.

ABC Example:

ABC Charity owns its own building and has parking expenses of \$40,000 for tax year 2018. It has no reserved parking for either employees or non-employees. Of the 200 parking spaces, 140 are utilized by employees during normal business hours.

UBI Calculation: ABC is subject to this parking tax since 70% of the parking lot is employee-utilized. ABC Charity has UBI tax of \$5,670.

UBI Tax Calculation: 140/200 = 70% x \$40,000 = \$28,000 less \$1,000 exclusion = \$27,000 x 21% = \$5,670

XYZ Example:

XYZ Association pays \$300 per employee per month for 5 employees to park in a garage. XYZ has UBI of \$14,600 and incurs UBI tax of \$3,066. Here's how those calculations work.

UBI Calculation: \$260 (maximum benefit allowed per employee) x 5 x 12 months = \$15,600 less \$1,000 exclusion = \$14,600 in UBI. The remaining \$40 per month per employee (\$480 annually) is reported as taxable compensation to the employee on their W-2.

UBI Tax Calculation: \$14,600 x 21% = \$3,066

Relief Window Closing March 31

Act Now. Relief exists, but it is timestamped! Change parking arrangements by March 31, 2019 and the IRS will consider that change retroactive to January 1, 2018. RUN, don't walk, to the parking lot and remove reserved parking signs. There is also relief in the form of penalty forgiveness for underestimated tax payments not paid timely going forward, but this relief applies only to the first two estimated tax payments.

As trusted advisors, CPAs should talk with all Nonprofit clients and assist with determining the applicability of this new tax and preparing the tax calculations (if necessary).

Per our contract with Sandestin, we earn complimentary rooms based on attendance if we meet our minimum percentage for the block. These rooms help defray the costs of housing the MSCPA staff and our speakers and entertainers. We can also be subject to a monetary attrition penalty if we do not utilize our group commitment. Even with rising meeting costs we continue to strive to hold a quality family oriented convention without passing the costs to our members. Please help the Society meet our goals! 


