MSCPA Supports

Calling for an Extension and **Expansion in Beneficial** Ownership Reporting Requirements



The Mississippi Society of Certified Public Accountants has joined AICPA and dozens of other state CPA societies to ask the Financial Crimes Enforcement Network (FinCEN) to extend and expand the deadline for beneficial ownership information (BOI) reporting requirements, specifically for Reporting Companies Created or Registered in 2024. The beneficial ownership information (BOI) reporting requirement requires small businesses, including small CPA firms and LLCs, to report information on the "owner" of an entity.

Effective **January 1, 2024**, existing companies, companies created or registered before January 1, 2024, will have one year, through January 1, 2025, to file their initial BOI reports. New companies, companies created or registered on or after January 1, 2024, will have 30 days to file their initial BOI reports. If there are inaccuracies in the initial BOI report filed or companies have a change in information, such as change in residential address or percentage of ownership, they will have 30 days to report changes or correct the inaccuracies.

The BOI reporting requirement is an anti-money laundering initiative enacted through the Corporate Transparency Act (CTA) in 2021, which mandates that BOI information is reported to (FinCEN).

In a comment letter, sent October 30, 2023, the profession specifically recommended that FinCEN extend the deadline from the proposed 90 days to one year and expand the applicability of the deadline to include not only new entities created in 2024 but

ALL entities created thereafter, as well as entities making updates or corrections to their original filings.

Lack of awareness is highlighted in the letter, citing that most businesses are not familiar with the new BOI regulation, despite the campaigns put in place to inform them. The time and financial burdens on small businesses were also mentioned as a potential result of not instituting the recommended changes. The comment letter also hopes to avoid the steep taxpayer penalties that could accompany unawareness of the new reporting requirements.

"MSCPA has joined the AICPA and other state societies to call for improving BOI reporting requirements," said Karen Moody, MSCPA President/CEO. "We believe that extending and expanding these reporting requirements will have a beneficial impact on taxpayers, small businesses and our members, who are serving as their trusted advisers."

CALL TO ACTION:

On December 12, 2023, the U.S. House of Representatives passed H.R. 5119, Protect Small Business and Prevent Illicit Financial Activity Act, providing a one-year delay to the start of the rule. MSCPA signed the letter to the House urging passage of the bill. Now, the U.S. Senate must take up this bill by December 31 or small businesses and the financial professionals who serve them will be working to navigate this new reporting requirement without clear guidance from FinCEN. Call our two U.S. senators and urge them to pass H.R. 5119 as passed by the U.S. House of Representatives before the end of the year!

- Credits expired between January 30, 2020 and December 31, 2023 are extended to June 30, 2025.



This conference was designed jointly by the AICPA and the CPA State Executives Association to prepare chief volunteer leaders for their year as Chair of their state CPA societies.

During the conference, participants networked with incoming Chairs from other state CPA societies and heard presentations on the most current professional issues.

AICPA 2023 Fall Council Meeting

The AICPA 2023 Fall Council Meeting was held October 18-19 in Pasadena, CA. Attending on behalf of the MSCPA were Jerry Goolsby (Chairman), Tom Walker (Vice-Chairman/Chairman-Elect), and Karen Moody (President/CEO).

The meeting focused on **Transformation & Growth Through**

Uncertainty. AICPA President/CEO Barry Melancon and AICPA CEO of Public Accounting Susan Coffey discussed the challenges faced by our country, including the Middle East conflict, US and China relations, Russia-NATO tensions and cyber attacks, all of which have an effect on the accounting profession. Other topics reshaping our profession included: AI, increasing CPAs as the trusted advisor, and higher and broader expectations of assurance. Members were also reminded that the new Quality Management Standards are effective December 15, 2025. Pipeline challenges took center stage with reports from the National Pipeline Advisory Group, round table discussions, and Council members participating in real-time surveys. There were also updates from FASB and GASB, state regulatory and legislative affairs, and NASBA.

Once again, the MSCPA was well represented by Jan Lewis who presented with Vice-President of Tax Policy & Advocacy Melanie Lauridsen on ERC, beneficial ownership information, 1099k section 174, and permanent e-signature. Jan is Immediate Past Chair of the AICPA Tax Executive Committee and serves on the AICPA Board of Directors.

Council will reconvene in mid-March for regional meetings, with the Spring meeting to be held in Orlando, FL on May 21-23, 2024.

Mississippi Individuals & Businesses Eligible for Tax Credit

Your Tax Liability . . . Give it to the Government . . . or Give it to Change Children's Lives.



Your clients can help children without affecting their budgets.

There exists an opportunity for Mississippi business owners and individuals to help provide homes, food, education, and medical care for at-risk children in Mississippi. They are able to do this without changing or increasing their budgeted charitable donations or expenses.

Here is how:

Passed in 2019 by the MS Legislature, the **Children's Promise Act** (MS code §27-7-22.39 & §27-7-22.41) allows business owners to receive a dollar-for-dollar tax credit of up to half their MS tax liability by gifting that portion to an Eligible Charitable Organization (ECO) like The Baptist Children's Village. Individuals may receive a tax credit of up to \$3,000 if filing jointly (\$1,500 filing single).

ADVOCACY LEGISLATIVE SPOTLIGHT

HOUSE BILL 1723: Credits Available for Contributions to Food Bank Charitable Organizations (FBCO)

Effective Date: July 1, 2023

House Bill 1723 of the 2023 Regular Session allows for a tax credit for voluntary cash contributions to eligible charitable food bank organizations (FBCO). This credit is available to taxpayers.

Total Maximum Allocation: \$1,000,000

Limits on Total Allocations per FBCO: N/A

Who can Qualify as an FBCO: Organizations that are exempt from federal taxation under Section 501(c)(3) of the Internal Revenue Code and who purchase, warehouse, and deliver food directly to food pantries or soup kitchens in more than five (5) Mississippi counties on a monthly basis

Who can Apply for an Allocation of Credit: Business Taxpayers (Corporations, Partnerships, Limited Liability Companies, and Sole Proprietorships)

Tax-Types that Credit can be used Against: Income Tax (50% of tax liability), Insurance Premium Tax (50% of tax liability), Insurance Premium Retaliatory Tax (50% of tax liability), Ad Valorem Tax (50% of real property tax liability)

Carry Forward: 5 years

Other Limitations: Contribution cannot be used for other state charitable credits and cannot be used as a deduction for state income tax purposes

How to Apply for Credits for Contributions to FBCOs:

Businesses must have their contribution(s) certified by completing the appropriate application at www.dor.ms.gov/credits/FBCO and sending it to the Department for review. Instructions are included in the applications. A letter response to the application will be sent within 30 days after receipt.


Lydia Windham 2023 Rising Star

IRS Announces Delay in Form 1099-K Reporting Threshold for Third-Party Platform Payments for 2023 & Announces Plans for Threshold of \$5,000 in 2024 to Phase Implementation

November 21, 2023

Following feedback from taxpayers, tax professionals and payment processors and to reduce taxpayer confusion, the Internal Revenue Service released Notice 2023-74 announcing a delay of the new \$600 Form 1099-K reporting threshold for third party settlement organizations for calendar year 2023.

As the IRS continues to work to implement the new law, the agency will treat 2023 as an additional transition year. This will reduce the potential confusion caused by the distribution of an estimated 44 million Forms 1099-K sent to many taxpayers who wouldn't expect one and may not have a tax obligation. As a result, reporting will not be required unless the taxpayer receives over \$20,000 and has more than 200 transactions in 2023.

Given the complexity of the new provision, the large number of individual taxpayers affected and the need for stakeholders to have certainty with enough lead time, the IRS is planning for a threshold of \$5,000 for tax year 2024 as part of a phase-in to implement the \$600 reporting threshold enacted under the American Rescue Plan (ARP).

Following feedback from the tax community, the IRS is also looking to make updates to the Form 1040 and related schedules for 2024 that would make the reporting process easier for taxpayers. Changes to the Form 1040 series – the core tax form for more than 150 million taxpayers – are complex and take time; delaying changes to tax year 2024 allows for additional feedback.

"We spent many months gathering feedback from third party groups and others, and it became increasingly clear we need additional time to effectively implement the new reporting requirements," said IRS Commissioner Danny Werfel. "Taking this phased-in approach is the right thing to do for the purposes of tax administration, and it prevents unnecessary confusion as we continue to look at changes to the Form 1040. It's clear that an additional delay for tax year 2023 will avoid problems for taxpayers, tax professionals and others in this area."

The ARP required third party settlement organizations (TPSOs), which include popular payment apps and online marketplaces, to report payments of more than \$600 for the sale of goods and services on a Form 1099-K starting in 2022. These forms would go to the IRS and to taxpayers and would help taxpayers fill out their tax returns. Before the ARP, the reporting

requirement applied only to the sale of goods and services involving more than 200 transactions per year totaling over \$20,000.

The IRS temporarily delayed the new requirement last year.

Reporting requirements do not apply to personal transactions such as birthday or holiday gifts, sharing the cost of a car ride or meal, or paying a family member or another for a household bill. These payments are not taxable and should not be reported on Form 1099-K.

However, the casual sale of goods and services, including selling used personal items like clothing, furniture and other household items for a loss, could generate a Form 1099-K for many people, even if the seller has no tax liability from those sales.


This complexity in distinguishing between these types of transactions factored into the IRS decision to delay the reporting requirements an additional year and to plan for a threshold of \$5,000 for 2024 in order to phase in implementation. The IRS invites feedback on the

threshold of \$5,000 for tax year 2024 and other elements of the reporting requirement, including how best to focus reporting on taxable transactions.

"The IRS will use this additional time to continue carefully crafting a way forward to minimize burden," Werfel said. "We want to make this as easy as possible for taxpayers. We will work to make the new reporting requirements easier for them, and we'll work closely with third party groups, tax professionals and others to find the smoothest path to ensure compliance with the law. This is consistent with our Strategic Operating Plan. The IRS is focused on meeting taxpayers where they are and helping them get it right the first time."

Expanded information reporting, which will occur as the result of the change in thresholds for Form 1099-K, is important because it increases tax compliance and can reduce burden on taxpayers seeking to follow the law. The IRS believes that expansion must be managed carefully to help ensure that Forms 1099-K are issued only to taxpayers who should receive them. In addition, it's important that taxpayers understand what to do as a result of this reporting, and that tax professionals and software providers have the information they need to assist taxpayers.


